

TradingView Subscription Promotion | zForex

Terms & Conditions

- **1. Introduction** This document outlines the terms and conditions for the zForex TradingView Subscription Promotion (the "Promotion"). By participating in this Promotion, clients agree to comply with the following terms and conditions. zForex reserves the right to modify, suspend, or terminate the Promotion at its sole discretion.
- **2. Promotion Period** The Promotion runs on a monthly basis. Eligible deposits and TradingView subscription rewards are calculated for each calendar month separately.

3. Eligibility

- The Promotion is available exclusively to individual traders with a verified zForex trading account.
- Corporate accounts, Introducing Brokers (IBs), and other non-individual accounts are not eligible.
- Participants must comply with <u>zForex's general Terms & Conditions</u> and KYC requirements.
- Z Forex Capital Market LLC does not accept clients from the Democratic People's Republic of Korea, Iran, Myanmar, United States of America, Turkey.
- **4. Promotion Details** Clients who make a raw deposit within the specified thresholds within a calendar month will receive a TradingView subscription as follows:

Deposit Amount (Raw Deposits)	TradingView Plan Provided
\$500 - \$999	Essential Plan
\$1,000 - \$1,999	Plus Plan
\$2,000 and above	Premium Plan

- Only raw deposits are considered; bonus funds are not included in the deposit calculation.
- Deposits must be made within a single calendar month to qualify for that month's subscription.
- The TradingView plan provided is valid for one month only and is subject to renewal based on meeting the deposit requirements in subsequent months.

5. Subscription Activation & Billing Policy

- The TradingView subscription will be activated within seven (7) business days following the end of the deposit month.
- If a client withdraws funds during the promotion period and the remaining balance falls below the required deposit threshold, the cost of the awarded TradingView subscription will be charged as a commission to the trading account.

6. Restrictions & Conditions

- Clients must maintain the required deposit threshold throughout the promotion period.
- Withdrawals before the end of the promotion period may result in the cancellation of the TradingView subscription or applicable charges.
- The TradingView subscription is non-transferable and cannot be exchanged for cash or trading credit.

7. Amendments & Termination

- zForex reserves the right to modify, suspend, or terminate the Promotion at any time without prior notice.
- The Promotion will be valid until 12.31.2025
- Any changes to the Promotion will be communicated via the zForex website or email notifications.
